

POWER OF ATTORNEY

KNOW ALL MEN by these presents that on the _____ day of _____, 20__ I, _____, holder of Account Number _____, of **Address** _____, in the **parish** of _____, and **Occupation** _____, do hereby **Appoint** _____, holder of Identification _____, **Date of Birth** / / , **Tax Registration Number (TRN)** _____ and **Address**, _____, in the parish of _____, and **Occupation** _____ (hereinafter called "My Attorney") my true and lawful Attorney to act for me and in my name and on my behalf to do, perform and execute the following acts and deeds which I am empowered to do, perform and execute, and to execute all or any of the following acts or things as he or she shall in my interest think proper:

1. **To negotiate**, carry into effect and perform all Agreements entered or that may be entered into by me with the Gateway Co-operative Credit Union (2017) Limited (hereinafter referred to as "the Credit Union").
2. To concur in doing the acts and things herein mentioned in conjunction with any other or others interested in the property I may acquire in the Credit Union.
3. **To operate my account** in the Credit Union and to open and operate on any new account, by deposit of any moneys which may come to the hands of my Attorney at the Credit Union and for such purpose to endorse all cheques made payable to me and to pay and disburse all sums of money for my account and to operate and draw cheques against my account standing in my name in the Credit Union as my Attorney shall think fit and sign and execute any receipts and other documents in order to withdraw moneys from any such last mentioned account and to enter any Safe Deposit Box in my name in the Credit Union.

4. Also, in my name and on my behalf **to draw, endorse, negotiate** and otherwise deal with cheques, bills of exchange, dividends, promissory notes, postal and money orders, treasury drafts and other drafts, mercantile instruments, interest warrants and negotiable instruments relating to my Credit Union account.

5. **To invest** any of my monies held at the Credit Union on my behalf, in such manner and at such rate of interest, in any product(s) offered by the Credit Union, as my Attorney shall in his absolute discretion think fit and from time to time to vary the said investments or any of them as my Attorney shall think fit.

6. **To exercise** for me and in my name all rights and privileges and perform all duties which now or hereafter may appertain to me as holder of an account at the Credit Union.

7. **To commence, carry on or defend** all actions and other proceedings touching my property or any part thereof or touching anything in which I may be in anyway concerned in the Credit Union.

8. **To settle, compromise or submit** to Arbitration all accounts, claims and disputes that may arise between me and my Credit Union and any other person(s).

9. **Generally, to act** in relation to my Credit Union account and to any property owned by me in the Credit Union as fully and effectually in all respects as I would do.

10. **To carry into effect and perform** all Agreements entered into by me with any other person.

11. **Generally, to do all such other lawful acts** and things as my Attorney thinks advisable for the purposes aforesaid as fully and effectively in all respects as I would do myself.

AND I HEREBY UNDERTAKE to ratify everything, which my Attorney shall do or purport to do in virtue of this Power of Attorney AND I DECLARE that this Power of Attorney shall be irrevocable for a period of _____ months from the date hereof.
